







#### NIMHD MISSION

NIMHD leads scientific research to improve minority health and eliminate health disparities. To accomplish this, NIMHD:

- Plans, reviews, coordinates, and evaluates all minority health and health disparities research and activities of the National Institutes of Health;
- Conducts and supports research on minority health and health disparities;
- Promotes and supports the training of a diverse research workforce;
- Translates and disseminates research information; and
- Fosters collaborations and partnerships.



# NIH 2008 Summit Recommendations Social Determinants of Health

- Conduct or support research methods that model the causes of health disparities in target populations: to examine social structures, social processes, spatial relationships, neighborhood factors, and environmental influences
- Investigate the social processes that support structural and institutional racism and other social determinants of health: to examine the extent to which discrimination, segregation, neighborhood conditions, and social determinants are risk factors for disparities in disease incidence, treatment, and health outcomes.



# NIH 2008 Summit Recommendations Social Determinants of Health

- Support research to advance methods and measurement of health literacy at the population and individual level
- Explore and examine the impact of health delivery system practices
- Research designs that enable prediction of potential consequences of policy changes on neighborhood, communities, environment, and health; and
- Evaluate economic burden and personal costs related to using health and social services among health disparity populations

#### NIH Health Disparities Strategic Plan Social Determinants of Health Priorities

- Develop and test a social determinants conceptual model for oral health
- Support and/or conduct research assessing and evaluating impact of neighborhood, local, state, and national policy measures on social determinants on health and health outcomes
- Support research to identify community-specific socio-cultural and systems/environment barriers, and to develop and test tailored stroke prevention and intervention strategies in underserved communities



#### NIH Health Disparities Strategic Plan Social Determinants of Health Priorities

- Research on the interrelationship of alcohol and the social and environmental factors that contribute to HIV infection, behaviors after infection, and co-occurring conditions
- Research to identify specific social exposures that have a persistent and negative influence on health care participation and outcomes
- Studies that focus on environmental (structural) prevention strategies that target the role of stress, poverty, racism and oppression on drug use

### **R01 Program Focus Areas**

Social, Behavioral, Health Services, and Policy Research on Minority Health and Health Disparities (RFA-MD-12-003)

- Social and behavioral determinants of health and disease
- Clinical efficacy and effectiveness of preventive and/or therapeutic interventions in community settings
- Examination of understudied health conditions
- Impact of health policies on health care access for disadvantaged populations
- Health services research



### **R01 Program Focus Areas**

Basic and Applied Biomedical Research on Minority Health and Health Disparities (RFA-MD-12-004)

- Studies of fundamental biological mechanisms underpinning health and disease in minority and health disparity populations
- Development of new therapeutic interventions to reduce or eliminate health disparities
- Clinical and translational research on the etiology and physiology of multiple disease conditions in health disparity populations
- Genetic risk factors for disease conditions, gene-environment interactions
- Pharmacogenomics and personalized medicine



### **Examples of R01 Research**

Social, Behavioral, Health Services, and Policy Research

- Influence of violence against women on cancer prevention and control
- Faith-based HIV intervention for middle-age and older African American women
- Risks associated with long-term care in Mexican-American families
- Health literacy disparities in teens with special healthcare needs
- Understanding disparities in patient-centered hospital care
- Effects of local housing policy changes on youth behavioral problems in low-SES communities



#### **Examples of R01 Research**

#### **Basic and Applied Biomedical Research**

- Genetic risk factors for kidney disease
- Biological and environmental modifiers of vitamin D3 and prostate cancer risk
- Weight gain, type 2 diabetes and factors that affect neuroendocrine function
- Impact of pneumococcal disease on Native American communities
- Culturally adapted depression intervention for African American adults
- Air pollution, stress and urban child development



### **R01 Program Highlights**

- 55 active projects totaling
- Half of all awards to date have gone to New or Early Stage Investigators, a much higher proportion than seen for all NIH R01 awards
- High interest in program among extramural research community, as reflected in rising numbers of applications
  - ❖160 pending FY 2013 applications for Social, Behavioral, Health Services, and Policy Research
  - 109 pending FY 2013 applications for Basic and Applied Biomedical Research
